The administrator system is a link in the chain of programs and a has to generate various documents and files or use various files and documents for statistical data in advance. Also he works in the executive function of the executive branch of the government along with other officials who are working on different functions in the government and is appointed by the president. The main objective of the administrator system is to ensure effective exercise of executive functions of the government by providing and controlling the facilities, resources and management for smooth functioning of administration. The administrator system is constituted under the State Administrative Council and is the body that acts as a link between the president and the State Legislature. It gives its functions to the state government and also to the subordinate government. Various government bodies also have subordinate and executive function under this body in the order of importance the Higher administrative services and the State Legislature. The administrator system is responsible for the coordination of various functions of the state. The State Administrative Council is the highest authority in the administrative system and the president is the supreme leader of this council. The State Legislature or the State Assembly and the Supreme Court are constituent bodies of the administrative system. The State Administrative Council advises the state government on different matters and has the power to enforce the orders of the administrative system in a given state. He can either provide help or cooperation or even make recommendations.But, the State Administrative Council cannot make any recommendation without executive functions of the state executive authority. In other words, the administrative council can give inputs to the government but it cannot levy any disciplinary action. It can be summoned only to appear before the administrative council. Only the executive department of the state government can send a representative before the administrative council to get the council's advice or make representations against the council. In general, the council gives its suggestions and ask for help in the areas of higher administrative service, state legislative service, the state judicial system and state judicial department, and the advisory and information service. The State Administrative Council comprises of three tiers namely, the president, vice president, and member secretaries. In every state, the president is the chairperson of the council and is the supreme leader. The vice president is the most senior member of the council followed by the secretary or the chairs of the committees or the bodies that are formed under the council. The member secretaries are the junior members of the council. The state legislature or the assembly is the constitutional authority of the government in the state and the State Administrative Council also functions as the legislative authority. The State Administrative Council sends its advice to the government only when it is requested by the government and the law does not exclude the council's advice. The supreme court has the authority

to make its orders and directions after taking the advice of the state administrative council. The supreme court can make orders or direct the State Administrative Council to send its recommendations to the government. The supreme court has the power to suspend or impose a fine on the state administration council for not implementing its advice or orders. The state administration council is responsible for coordinating and enforcing the instructions or orders of the government under the constitution of every state. The State Administrative Council is appointed by the president and has to pass its instructions to the state government. The state administrative council has to continue its functions until the president is removed and also if the president dies or resigns. The supreme court has the power to review the instructions given to the state administration council and also the state administrative system can only be compared with the administrative authority of the central government as it coordinates the functions of various governments in each state. Although, the state administration council is not responsible for legislating or giving law under the constitution of executive functions of the government.
