We do not agree that Brown had a constitutional right to representation by counsel at the termination hearing, however. It is only if the state, through its agents, threatens to deprive an individual of his liberty that the state must provide the individual with procedural due process, which includes the right to counsel. Wolff v. McDonnell, 418 U.S. 539, 564-65, 94 S.Ct. 2963, 2979-80, 41 L.Ed.2d 935 (1974). The United States Supreme Court has held that no such proceedings are implicated where the decision to revoke good time "has been entirely administrative, in the sense that no evidence has been presented to the administrative tribunal, and none has been introduced in any subsequent judicial proceeding." Id. at 569, 94 S.Ct. at 2981. Since the revocation of good time in the case at bar was entirely administrative in nature, there was no need for counsel to be present at the hearing. As to the admission of the testimony of the witness Cynthia, the ALJ ruled that it was not within her province to rule upon the reliability of evidence introduced at the hearing. The ALJ is required by § 10-9-105(a) to reject hearsay in the disciplinary proceeding. Any evidence of a "serious nature" is required to be presented to the board of freeholders of the sentencing county. There was no compliance with the statute or rule. The ALJ was correct in ruling that she had no authority to make a finding of fact regarding the reliability of evidence that was not presented. The board of freeholders could have made an independent determination of the reliability of Cynthia's testimony had they chosen to do so, but they did not. In its brief, the state attorney does not argue that the board of freeholders is competent to make such a determination. We do not think that the board of freeholders is competent to make
