EMCCS Liability Form

The undersigned being the lawful parent(s) and/or guardian(s) of the applicable child(ren), hereby consent to the participation by the child(ren) in all child care activities and services conducted and provided by Evening & Morning Child Care Services LLC (EMCCS) and to the participation of the child(ren) in all events related to previously said activities and services.

The undersigned hereby further authorizes any of the EMCCS staff and representatives of EMCCS to provide for, approve, and authorize any health care at any hospital, emergency room, doctor's office or other institution, employ any physicians, dentists, nurses, or other person whose services may be needed for such health care, review and if necessary disclose the contents of any medical records, execute any consent form required by medical, dental, or other health authorities incident to the provision of medical, surgical, or dental care to the child(ren). Health care shall include, but not be limited to the administration of anesthesia, x-ray, examination, performance of operations, diagnostic, and other procedures. It is the express responsibility of the Parent/Guardian to inform of any pre-existing conditions that may affect the health of the child and that duty is an ongoing one for updating EMCCS Management with any relevant changes?

The undersigned hereby further authorizes emergency transportation by either EMCCS child care staff or, if determined necessary by a EMCCS child care staff member, by ambulance or other emergency vehicle. If there is no medical emergency, the EMCCS child care staff will first use reasonable efforts to contact the parent(s) and/or guardian(s) before administering or authorizing any treatment. Notwithstanding other provisions in this consent form, EMCCS staff shall not have the authority to withhold or withdraw life-sustaining procedures for the child(ren). Please be advised that day trips or field trips may entail additional risks associated with travel and circumstances that are beyond the control of EMCCS and cannot be held liable for. Signed field trip permission slips are required to participate in day trips and any needed transport will be performed by a third-party transportation professional, not by EMCCS.

The facilities used by EMCCS are child-proofed and all children are consistently well supervised. However, accidents do happen. The undersigned assumes all risk of injury or harm to the child(ren) associated with participation in the child care and agrees to release, indemnify, defend, and forever discharge EMCCS staff and employees from all liability, claims, demands, damages, costs, expenses, actions, and causes of action in respect of death, injury, loss, or damage to the child(ren), or by the child(ren), howsoever caused, arising or to arise by reason of or during the child(ren)'s participation in the child care services provided by EMCCS.

Additionally, I the parent/guardian give my consent that my child(ren), should they participate in EMCCS photography or videography, that content be may legally used including but not limited to: publicity, copyright purposes, illustration, advertising, web content, and etc. Furthermore, I understand that no royalty, fee, or other compensation shall become payable to me or child(ren) by reason of such use. EMCCS staff and/or its representatives maintain full and exclusive rights, but will be respectful of likeness use and/or related purposes.
